Deputy Commissioner (Nicobar) in her opening remarks welcomed the members of monitoring committee to oversee welfare and issues related to Shompen and Nicobarese regarding Holistic Development of Great Nicobar Island project. As decided in the last joint monitoring committee meeting held on 30.04.2024, the draft monitoring framework to oversee Tribal related matters was submitted to all the committee members vide email dated 26.09.2024.

Senior Consultant (Environmental Planner), ANIIDCO made a presentation briefing the background, key projects involved, status of the project, draft monitoring framework which was circulated to all members vide email dated 26.09.2024 and budget of Tribal welfare plan & Special medical unit.

As per EC & CRZ Conditions, proposal for Tribal welfare plan prepared by Tribal Welfare Department and setting up of special medical and health care unit for prevention and control of diseases with special reference to tribal populations prepared by Department of Health Services has been submitted to MoEF&CC and MHA.


It was clarified that the role of the committee is to review the progress of work of respective areas and implementation of mitigation measures and advise further on its implementation.

The following are the discussion & suggestions made by the committee:

1. ANIIDCO to share the copy of tribal welfare plan and proposal for special medical unit submitted by Tribal Welfare & Health Department respectively.
2. ANIIDCO informed that Tribal welfare plan amounting to Rs.75 Crores and proposal for setting up of Special Medical Unit amounting to Rs.126.98

- Crores submitted to MHA for budgetary sanction which is under process.
3. Shri. Som Naidu, Tribal Welfare Expert, expressed his satisfaction with the welfare plan developed by the Tribal Welfare Department and stated that the interventions outlined in the plan would support socio economic development while safeguarding that the recommendations made by the Empowered committee and the provisions of the Shompen Policy should be followed strictly.
  4. Shri. Pronob Sircar, Tribal Welfare officer submitted that there is no proposal to displace Tribal population due to upcoming project as per the recommendations of Empowered Committee.
  5. Shri. Sandeep from Tribal welfare Department confirmed that the budget of geo-fencing activity incorporated in the Tribal welfare plan.
