Minutes of the Monitoring Committee meeting to oversee the pollution related matters held at 04:00 pm on 25.03.2025 under the chairmanship of Member Secretary, Andaman & Nicobar Pollution Control Committee (ANPCC) at Conference Hall, ANIIDCO Ltd., Sri Vijaya Puram for Holistic Development of Great Nicobar Island project.

Chairman/ Member Secretary, ANPCC welcomed the members of Monitoring Committee and project implementing agencies. ANIIDCO made a presentation on the decisions taken in the previous meeting and requested project implementing agencies to present the project status, the updated Environmental Management Plan for the construction and operation phases, and the Environmental Monitoring Program. The Chairman requested the project implementing agencies to share the current status of their projects and asked committee members/field experts to provide comments, if any, on the response submitted via email on 18.03.2025 regarding the comments raised by members in the last meeting.

The following are discussion & suggestions of the committee:

- 1. Syama Prasad Mookerjee Port, Kolkata (SMPK), informed that the Detailed Project Report (DPR) has been submitted for approval to the Ministry of Ports, Shipping and Waterways (MoPSW), and the decision on the project implementation strategy will be finalized in the upcoming 9<sup>th</sup> HPC meeting. Accordingly, the updated Environmental Management Plan (EMP), in compliance with EC & CRZ conditions, will be incorporated into the DPR.
- 2. NTPC Limited informed that the DPR is under process, and the EMP, in compliance with EC & CRZ conditions, will be incorporated into the DPR.
- 3. M/s. Egis India Consulting Engineers Pvt. Ltd., the Master Plan Consultant for the Township project, informed that the revised Master Plan notification report was submitted on 04.03.2025, and the DPR for the Township will be submitted by April 2025. Accordingly, the updated EMP for the Township, in compliance with EC & CRZ conditions, will be incorporated into the DPR.
- 4. ANIIDCO requested all the project implementing agencies to update their project

- specific Environmental Management Plan (EMP) and Environment Monitoring Program in compliance with EC & CRZ conditions.
- 5. Dr. Mukesh Sharma, Air Expert suggested that a brief report on the action taken towards EMP during construction and operation phase & Monitoring programme, to be submitted on regular basis once the project gets commenced.
