NOTIFICATION

Port Blair, dated the 21st April, 2015.

No.62/2015/F.No.24-32/2012-2013/Excise (PF-II).— In exercise of the powers conferred by Sub-Section (1) of Section 28 of the Andaman and Nicobar Islands Excise Regulation, 2012 and in supersession of this Administration's Notification No.27/2014/F.24-32/2012-2013/Excise dated 17.02.2014 as published in the Andaman and Nicobar Gazette Extraordinary No. 28 dated 17.02.2014, the Lieutenant Governor (Administrator), Andaman and Nicobar Islands hereby prescribes the rates of Excise Duty on ad-valorem basis payable by the persons manufacturing/producing or importing into the Union Territory of Andaman and Nicobar Islands or selling the kinds of liquor as described in the Schedule given below at the rates specified against each.

SCHEDULE

1.	IMFL (LSP upto Rs. 50/- per bottle)	200% of last selling price
2.	IMFL (LSP Rs. 51 to Rs. 60/- per bottle)	180% of last selling price
3.	IMFL (LSP Rs. 61 to Rs. 75/- per bottle)	150% of last selling price
4.	IMFL (LSP Rs. 76 to Rs. 100/- per bottle)	125% of last selling price
5.	IMFL (LSP Rs. 101 to Rs. 150/- per bottle)	100% of last selling price
6.	IMFL (LSP Rs. 151 to Rs. 200/- per bottle)	75% of last selling price
7.	IMFL (LSP Rs. 201 to Rs. 400/- per bottle)	55% of last selling price
8.	IMFL (LSP Rs. 401 to Rs. 1000/- per bottle)	30% of last selling price
9.	IMFL (LSP above Rs. 1000/- per bottle)	10% of last selling price
10.	Wine	5% of last selling price
11.	Lager Beer	25% of last selling price
12.	Strong Beer	75% of last selling price
13.	Ready to Drink (RTD)	5% of last selling price

This Notification shall come into force with immediate effect.
